

# **Industry update**

TPAF brings to its patrons a new section which will showcase a key piece of news, information, and insights related to the organ transplantation sector. It will focus on trends, developments, and changes within the sector.

In this edition we bring to you the key highlights from the NOTTO Annual Report-2023-24 -Under "One

Nation One Policy" the following reforms have been informed to the States for implementation:

- a. Condition of State domicile for registration of recipients to receive deceased donor organ transplantation has been removed.
- b. Upper age limit for registration of recipients for receiving deceased donor organ has been removed i.e. Now, a person of any age can register for receiving deceased donor organs.
- c. No fees to be charged for registration of patients for receiving deceased donor organs.
- Development of Uniform Organ Transport Policy for the country, consultations were held with following
- 7 Ministries coordinated by NITI Ayog -The key statistics of organ donation and transplantation for the

#### year 2023

- a. Total 18,378 organ transplants were performed which is highest in the last 10 years
- b. Kidney transplants account for 73% of total transplants followed by liver (24%), while heart, lung, pancreas and small bowel transplants together comprise of the remaining 3%
- c. 84% of these were living donor and remaining deceased donor transplant with a minor proportion of domino transplants
- d. There is a 3X increase in deceased donors with a 3.5X rise in average transplants performed per donor
- e. Top 5 states performing deceased donor transplants- Tamil Nadu, Telangana, Karnataka, Maharashtra, Gujarat
- f. Top 5 states performing living donor transplants- Delhi NCR, Tamil Nadu, Maharashtra, Kerala, West Bengal
- -The key statistics of Liver donation and transplantation for the year 2023
- a. Total 4,491 Liver transplants were performed, out of which 511 Pediatric Liver transplants (PLTs)
- b. Out of the 511, 492 were living donor, 17 deceased donor & remaining 2 domino transplants
- c. Top 5 states performing Liver transplants (85% of the total)- Delhi NCR, Tamil Nadu, Maharashtra, Telangana, Kerala
